Giving tax-efficiently

UK taxpayers can increase the value of your gift(s) of any amount to ICS at no extra cost to you using the Gift Aid scheme if (during a tax year) you pay an amount of UK income or capital gains tax equal to or greater than the amount of tax we will reclaim on your gift. Under the scheme we can reclaim from the Inland Revenue £2.82 for every £10 you donate (tax year 2010 – 2011; thereafter £2.50). Please complete the Gift Aid declaration on page one if you are eligible. If your tax position (such that you can no longer use the Gift Aid scheme), name or address changes, please notify ICS immediately. We may periodically ask you to re-confirm your tax status. US taxpayers may make donations in excess of \$500.00 tax-deductibly via CAFAmerica. To use CAFAmerica tick the box on page two for a form, or donate online at www.cafonline.org/cafamerica/ or via the link on ICS's home page.

Gifts made to this appeal do not count towards annual ICS Membership subscriptions and are accepted in accordance with our general policy concerning gifts for specific objectives or projects which is that if a donor requires the Society to apply a donation for specific objectives or projects (whether in response to a specific appeal or otherwise) and the amount(s) received exceed(s) the sum(s) necessary to fund these objectives or projects, or if it is not possible or appropriate for any reason to fulfil or proceed with the stated objectives or projects, the Society will use the excess or all of the donation(s) received for its general charitable objects. For legal and accounting reasons, we regret that we cannot accept donations on any other basis. **Data Protection** ICS will store information about you on its database, but does not pass mailing lists to third parties.
